Portfolio Manager Commentary

The Carpe Diem Canada basket delivers solid long-term performance, up 16.6% over the last year, and up 11.39% annualized since inception (May 2021).

Carpe Diem Canada performance benefited from the Canadian financial sector exposure and dividend payers, while the energy sector was a detractor.

Looking ahead, the unpredictable US tariff policy is a negative for Canadian productivity. Increasing economic and geopolitical risks, alongside fairly valued Canadian stock market valuations, will likely lead to a more volatile second half of the year. In this environment, investors should stay diversified, be patient, and dollar cost average-in as opportunities arise.

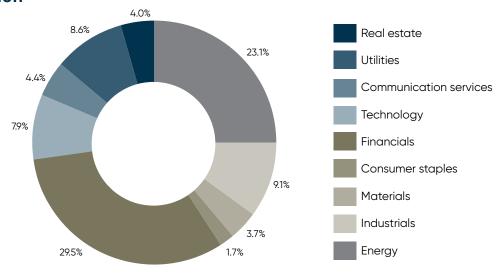
